Dear Sir/Madam,

On the basis of your application/self declaration cum form-1 and subsequence correspondence/inspection a temporary recognition is being granted to your school for classes I to VIII from session 2016-17 onwards subject to following conditions

1. The grant for recognition is not extendable beyond class VIII and does not in any way imply any obligation to recognize or affiliate
2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act-2009 and the Right of Children to Free and Compulsory Education Rules-2011
3. The School shall admit in Class I to the extent of 25 % of the strength of that class children belonging to weaker section and disadvantaged group in the neighborhood and private free and compulsory elementary education till its completion (Provided, that in case of pre primary classes also, this norm shall be followed)
4. For the children referred to in paragraph 3, the school shall be reimbursed as per Section 12 (2) of the Act. To receive such reimbursements school shall provide a separate bank account
5. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure
6. The School shall not deny admission:
 - a) To any child for lack of age proof
 - b) If such admission is sought subsequent to the extended period prescribed for admission
 - c) On the ground of religion, caste or race, place of birth or any of them
7. The School shall ensure that:
 - a) No child admitted shall be held back in any class or expelled from school till the
 - b) No child shall be subjected to physical punishment or mental harassment completion of elementary education in a school,
 - c) No child is required to pass any board examination till the completion of elementary education
 - d) Every child completing elementary education shall be awarded a certificate as laid down under Rule 21
 - e) Inclusion of Students with disabilities/special needs as per provision of the Act
 - f) The teachers are recruited with minimum qualifications and are provided with minimum salary and allowances as laid under section 23(1) of the Act provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years
